- *Rates based off of small cell counts of 0, 1, 2, 3, and 4 have been suppressed to protect patient confidentiality. In some cases secondary suppression was used to suppress rates based on cell counts >4 to prevent reverse calculation of totals to identify small cell counts.
- No personal exposure information is available, including smoking history, diet, or lifestyle.
- County Rates are calculated by using each county's population distribution
- Unknown County rates are calculated by using Missouri's population distribution
- All rates do not include cases where the age was unknown
